This CLARIFICATION AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR GLEANNLOCH FARMS ("Clarification Amendment") is made on the date hereinafter set forth by Champions Glen, L.P., a limited partnership organized under the laws of Delaware.

WITNESSETH:

WHEREAS, Declarant filed that certain Declaration of Covenants, Conditions and Restrictions for Gleannloch Farms on the 9th day of January 1998, recorded under Harris County Clerk's File Number S808820, in the Official Public Records of Real Property of Harris County, Texas (hereinafter referred to as the "Original Declaration"); and

WHEREAS, the Declarant filed that certain First Amendment to the Declaration on the 3rd day of February 1998, recorded under Harris County Clerk's File Number S843054, in the Official Public Records of Real Property of Harris County, Texas (hereinafter referred to as the "First Amendment"); and

WHEREAS, the Declarant filed that certain Second Amendment to the Declaration on the 26th day of February 1999, recorded under Harris County Clerk's File Number T568628, in the Official Public Records of Real Property of Harris County, Texas (hereinafter referred to as the "Second Amendment"); and

WHEREAS, the Original Declaration, the First Amendment, the Second Amendment, and this Clarification Amendment are referred to hereinafter collectively as the "Declaration"; and

WHEREAS, All capitalized terms are as defined herein and in the Declaration.

WHEREAS, the Declaration vests the Declarant with the authority to unilaterally amend the Declaration to clarify or resolve ambiguities or to correct any inadvertent misstatements; and

WHEREAS, the Declarant has determined that there is a misstatement in the Original Declaration that needs to be clarified.

NOW THEREFORE, pursuant to the authority vested in the Declarant, the Declaration is hereby amended as follows:

That portion of Article V, Section D 1, Voting Procedures, that currently reads as follows:

Every Lot shall be located within a Neighborhood, as designated by Declarant.

shall be amended to read as follows:

Every Lot may be located within a Neighborhood, as designated by Declarant.

That portion of Article V, Section D 2 that currently reads as follows:

Each Neighborhood shall have a Neighborhood Committee and shall be represented by a Neighborhood Representative.

shall be amended to read as follows:

Each Neighborhood may have a Neighborhood Committee and may be represented by a Neighborhood Representative.
